Dear Chairman Manchin and Ranking Member Barrasso,

We are a group of environmental and environmental justice (EJ) organizations focused on centering environmental justice in federal climate policy. We have advocated collectively for the equitable implementation of billions of dollars of investments in the Inflation Reduction Act (IRA) for key environmental justice programs. On behalf of environmental justice communities we represent from across the country, we express deep concern over the Energy Permitting Reform Act of 2024 and similar energy permitting proposals, that undermine the environmental justice provisions in the IRA<sup>1</sup> and serve as giveaways to the fossil fuel industry.

We strongly oppose any effort to further expand oil, gas lease sales, undermine the Biden administration's pause on liquefied natural gas (LNG) exports, loosen oversight of drilling and mining projects, and curtail the public's ability to challenge harmful energy projects. Harmful energy permitting proposals will exacerbate environmental burdens<sup>2</sup> and public health risks for communities by making it easier for the fossil-fuel industry to site polluting projects in our communities and to perpetuate the industry's practice of concentrating destructive projects in communities of color and low-income communities.

We support clean, renewable, transmission infrastructure that is needed to achieve climate goals and combat fossil-fuel reliance. Communities must not be sacrificed in the process. Policy makers should focus instead on passing legislation such as the A. Donald McEachin Environmental Justice for All Act<sup>3</sup>,

which clarifies how agencies consider and address the cumulative, and often disproportionate<sup>4</sup>, impacts from project development in communities of color and low-income communities. An equitable and just buildout of clean energy infrastructure should not add additional burdens to communities who are already overburdened by cumulative impacts. To this end, it must incorporate adequate environmental and social impacts review processes, meaningful and substantive participation from affected communities, and honor a communities' right to refuse the siting of harmful projects. This will ensure that projects proceed not just efficiently, but equitably, in the communities where they matter most.
